The combination of PTFE, fiberglass and a high temperature silicone adhesive allows A2005 to perform in continuous temperatures up to 500°F. A2005 is dimensionally stable and resistant to tears, punctures, abrasion and wear. It will not “cold flow” under heavy loads.

**Availability**—A2005 is available in widths from 1/4" to 36" wide. Standard roll length is 18 or 36 yards long. A2005 is available with or without a liner.
